General Conditions/Instructions:

1. Applications filled only in prescribed format will be entertained.
2. Incomplete applications and/or applications received after the due date shall summarily be rejected and no further correspondence in this matter shall be entertained.
3. Vacancies are tentative and may increase or decrease. Institute reserves the right to fill or not to fill any or all of the vacancies advertised.
4. The pay level carry other allowances admissible as per Government of India rules. Fresh appointees will be covered under the New Pension Scheme (NPS-2004) as per Government of India rules.
5. Applications received in response to the advertisement for the post mentioned above will be scrutinized and short-listed candidates on the basis of written examination only will be called for interview.
